The Governor of Punjab is pleased to appoint the Punjab State Board of Technical Education & Industrial Training, Chandigarh (hereinafter the Board) as the authority competent to conduct the on line counseling on the basis of merit of qualifying examination for admissions to various diploma level courses being run in all the Polytechnics/Institutions located in the State of Punjab, which stand approved by the All India Council of Technical Education for the session 2016-17 except for Part Time courses, MOP and Pharmacy as per the prescribed intake for morning and evening shifts. Any addition of courses or any increase or decrease in the seats for the year 2017-18, the Board is authorized for affiliation of the Polytechnics/Institutes at its own level as per the procedure laid down on the basis of the approval of All India Council of Technical Education.

The Board shall make admissions, subject to affiliation granted by it to these institutions.

A) <u>ELIGIBILITY FOR ADMISSION TO DIPLOMA LEVEL COURSES</u>

The admission to the Diploma level Courses shall be online counseling on the basis of merit of qualifying examination.

From the Academic session 2017-18, 85% seats shall be reserved for the internal candidates from within the State of Punjab and 15% shall be open to all candidates on All India basis.

The Eligibility criteria for 85% seats will be that candidate shall be a resident of Punjab State as per Punjab Government, Department of Personnel and Administrative Reforms (PP-II Branch) letter No. 1/3/95-3PPII/9619 dated 6th June 1996 and letter No. 1/3/95-3PPII/81 dated 1st January, 1999 or shall have passed the matriculation examination from an institution/school affiliated to Punjab School Education Board/CBSE/CSE/National Open School situated in Punjab. The candidate would be required to submit a certificate to this effect from the Principal/Head of Institution last attended in the prescribed proforma as given in the prospectus.

IV. Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as mentioned in Punjab Government, Department of Technical Education and Industrial Training Memo. No. 35/44/95-1TE(2)/978 dated 21st March, 2003.

The State Board of Technical Education and Industrial Training, Punjab shall follow a proper process for making such admissions.

VI

Admission of candidates, who fulfill all eligible conditions, shall be made on the basis of the relative merit subject to reservation of seats, detailed instructions in respect of which are given in Section-E.

VII.

The students shall pay the fees/ development fee and other charges, as per rates of fees/development fee and other charges as fixed by the Government of Punjab/Union Territory of Chandigarh or the Board.

VIII.

The fee structure for Foreign Nationals/Person of Indian Origin shall be the same as for NRI candidates.

IX.

The guidelines for admission of Kashmiri migrants shall be as per Punjab Government Notification No. 35/44/95-ITE2/3244 dated Chandigarh the 30th August 2001.

X.

The guidelines for admission of Foreign Nationals/ Persons of Indian Origin shall be as per Punjab Government Notification No. 13/75/2001-ITE2/296 dated Chandigarh the 23rd January, 2002.

XI.

The guidelines for admission of Sikh minority community students to Guru Nanak Dev Polytechnic College, Ludhiana and Baba Banda Singh Bahadur Polytechnic College, Fatehgarh Sahib shall be as per Punjab Government Notification No. 18/33/2000-GC (6) 4513 dated Chandigarh, the 3rd April, 2001.

XII.

The management quota shall be as per Punjab Govt. Department of Technical Education and Industrial Training No.13/129/03-1TE2/1247 dt. 25th April 2008, No.13/129/03-1TE2/1892 dt. 20th June 2008 and No.13/129/03-1TE2/171 dt. 18th January 2011 as amended from time to time.

XIII.

There shall be no bifurcation of the seats into "free seats" and "paid seats" This is in compliance with the judgment of the Hon'ble Supreme Court of India vide its judgment the case of <u>T.M.A. Pai Foundation and other vs. State of Karnataka and others ((2002) 8 SCC 481: AIR 2003 SC 355)</u>,and the instructions of Government of India, Ministry of Human Resource Development and the AICTE.

XIV.

Academic session may commence on 16th July 2017, if it happens to be holiday, then the academic session shall commence on next working day.

RESERVATION:

The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13/2/05-1TE2/1987 dated 2nd July, 2013. As regards the reservation of seats of Chandigarh Polytechnics, the same shall be as per the policy intimated by the Chandigarh Administration to the Board.

The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the certificates that have been issued on or before the last date of counseling shall only be accepted. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the cut-off

date, otherwise their certificates shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances. This provision should be given wide publicity and also included conspicuously in the prospectus—cum-information brochure to be issued by the Board.

- III. The Board shall make a provision in the Admission application form for the candidates to indicate the category, if any, under which they are seeking reservation. In case of reservation is claimed in the application form, candidate shall be treated as general category. The Government of Punjab may also set up a Committee to effect inter se gradation of candidates claiming reservation under certain categories, as indicated in the aforesaid memo dated 20th March, 2003. In the absence of this Committee, the Board shall effect this inter se gradation, in accordance with the criteria laid down in the aforesaid memo dated 20th March, 2003.
- IV. A candidate shall be eligible to make claim for reservation under one reserved category only. However, the procedure for counseling/ allotment of courses and/ or institutes shall be such that if a candidate is getting a course/ institution higher in his/ her order of preference, as a general candidate, he/ she shall be so regarded, notwithstanding his/her claim as a reserved category candidate. The seat under the reserved category shall then be offered to the candidates in that very reserved category.
- V. The unfilled seat in any reserved category shall be merged in the General Category quota after all eligible candidates of the reserved categories have been called for counseling.

C. ONLINE- COUNSELLING

- For admission to various Diploma Courses web based online counseling shall be followed for the Academic year 2017-18 and therefore physical presence of candidates for the counseling will not be necessary.
- II. During the online counseling, candidate shall be given opportunity to exercise choice of institutes / trade in centralized counseling and thereafter the vacant seats, if any, shall be filled by the institute on the criteria of admissions under management quota.
- There shall be two rounds of centralized counseling by State Board of Technical Education, Punjab Chandigarh. The 2nd counseling should be over by 10th of July 2017 and the admission consequent to this, should be allowed till 15th July. Thereafter the direct admissions at the college level shall be allowed for vacant seats and the Punjab State Board of Technical Education Punjab, Chandigarh will issue necessary instructions to the institutions on 16th July 2017 in this regard. The process of online registration of such seats should be completed by 15th August by all means.

E FEE WAIVER SCHEME

I. The Admissions under Fee Waiver Scheme of AICTE, shall be made by Punjab State Board of Technical Education & Industrial Training through online counseling simultaneously with general counseling in supersession of the Govt. Notification No. 13/60/08-1TE2/1797 dated 23.05.2011, No.13/60/08/1TE2/2007 dt. 31/5/2012 and Memo No.751-752/A-1/ECC/2015 dt.13/5/2015 as per the terms and conditions laid down by All India Council of Technical Education from time to time.

F OVER-RIDING PROVISION:

- Nothing in this notification shall be operative in so far as it is inconsistent with the law of the land as laid down of the judgment of the Hon'ble Supreme Court of India in the case of T.M.A. Pai Foundation and other vs. State of Karnataka and others ((2002) 8 SCC 481: AIR 2003 SC 355). Any such inconsistency may be brought to the notice of the Government of Punjab, clearly highlighting the inconsistency, for immediate rectification.
- II. The institutions which do not make admission on the basis of the Central Admission procedure as notified by the Board, from time to time or violate any of the above terms and conditions, shall automatically stand disaffiliated from the Board without any further notice.
- III. The notifications, circulars and instructions of the Government of Punjab as referred to in A-III,A-IV,A-IX,A-X,A-XI, A-XII,A-XIII, A-XV, B-I, D-I and E-1 in this notification shall be treated as part of this notification for all purposes and all the provisions of this notification shall be read along with the contents of said notification/ circulars and instructions.


